RFI's:

• Can wood doors manufactured from VT industries be supplied?

- It's too late to evaluate for substitutions. Possibly post contract award and provided it meets the current spec.
- Will there be a more detailed accessory schedule?
 - Not at this time
- I cannot locate any information about the size of this logo piece, material to be used, where it goes, etc. There are no signage specs at this time.
 - Owner will handle the signage as per Addendum #1
- Purlin reinforcing for suspended ceilings: a more economic way to approach this
 would be to utilize the new partitions for ceiling in place of joist reinforcing.
 - Please bid per the construction documents. This can be evaluated after bid award as a potential cost savings to the owner.

- Various questions regarding the framed openings in the existing wall at parapet wall locations.
 - Our design intent is the new parapet area be a cold formed steel stud curtain wall and the openings be framed per CFS details on S4.1(S3.1 keyed note 6 plan note G). Where existing girts and panels are to remain with new openings installed it is our intent to provide new C girt framing. (keyed note 5 on S3.1, detail 7/S4.1).
- Please clarify what size tiles you would like for the FRP. The spec mentions 4" x 4" and 8" x 8".
 - The previous RFI response indicated FRP to be installed only at the mop sink. This was incorrect. W1 and W2 wall coverings as listed in the finish schedule and finish plan are to be installed per the drawings.

No further RFI's will be addressed.


